# **Parking laws – the basics**

The law says you have parked even if you only stop for a few minutes or do not leave your vehicle.

Every time you park your car or vehicle, you must:

- obey relevant parking signs
- park within marked bays (if marked)
- not get in the way of traffic, cyclists or pedestrians
- allow enough space for large vehicles to pass safely (usually three metres).

Before leaving the vehicle, you must:

• make sure the parking brake is on

MINUTE

- · remove the key from the ignition
- lock all doors and windows if there is no-one in the vehicle
- check for traffic and cyclists before opening your door, getting out of or off the vehicle.

# **Parking signs**

- Read parking signs from top to bottom, left to right. It is important to read the whole sign.
- The time limits on a parking sign only apply during the times shown. Outside of those times, you can park for as long as you want, unless another sign says you cannot.
- Once you have reached the time limit, you cannot add more money to the meter or move to a nearby spot. You must move your vehicle out of the area that the sign applies to.
- If a parking sign shows a day of the week (for example, Monday) then the restriction does not apply when that day is a public holiday.
- If a parking sign does not show a day of the week then the restriction applies every day, even on public holidays.

## What if there is no sign?

Generally, parking signs tell you whether you can park. However, even if there are no signs there are situations where you:

- cannot stop or park
- must leave enough space between your vehicle and something else.

# **Parking fines**

A parking fine is also called an infringement notice.

You can get a fine even if someone stays in the vehicle.

Never ignore a parking fine – fines do not go away. Act early to avoid having:

- to pay more
- to go to court
- your licence or registration cancelled.

You may be able to get free legal help for your fine.

## Who can give me a parking fine?

Only authorised people can give you a parking fine. These include:

- police
- protective services officers (PSOs)
- some council, government and VicRoads officers.

Private companies run some carparks. A parking 'fine' from a private company is not the same as a fine from a council, the government or police. Visit our website to learn more.
